Sub: Intimation under Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations')

Pursuant to Regulation 30 read with Para A of Part A of Schedule III of Listing Regulations, we hereby inform you that the Company has received the following Orders:

- From Assistant Commissioner of Central Tax, Hyderabad under Section 50, Section 74 and Section 140 of Central Goods and Service Tax Act/ Telangana Goods and Service Tax Act for Tax liability amounting to Rs 21,29,859 and a Penalty of Rs 21,29,859 aggregating to a demand of Rs 42,59,718. The said demand pertains to GST Audit conducted by Telangana state GST Department for the period 2017 - 2018.
- From Joint Commissioner of State Tax, Hyderabad under Section 73 of Central Goods and Service Tax Act/ Telangana Goods and Service Tax Act for a Penalty of Rs 1,47,714. The said demand pertains to GST Audit conducted by Telangana state GST Department for the period 2017 - 2018.

Based on our assessment, we believe that the aforementioned demands are not maintainable and the Company is in the process of preferring appeals against the said Orders. Both the Orders have no material impact on the financials, operations or other activities of the Company.
