## Sub.: Update on Intimation filed under Regulation 30 the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations')

We refer to our letter dated August 14, 2023 ('letter') wherein the Company had, in accordance with Regulation 30 read with Para B of Part A of Schedule III of the Listing Regulations and SEBI circular dated July 13, 2023, informed the Stock Exchanges about the pending litigations/disputes (Material Disclosure).

The Annexure H to the Material Disclosure included information in relation to the litigation regarding four disputes with Service Tax Authority, West Bengal, for an aggregate amount of Rs 110.86 crores.

In this regard, we would like to inform you that, for one of the matters, the Company has received an order from Custom, Excise and Service Tax Appellate Tribunal, Kolkata (CESTAT) remanding the matter back to the Adjudicating Authority for considering the matter on merit and limitation.

The copy of the said order was uploaded on website of CESTAT on February 8, 2024 which was downloaded by the Company on February 9, 2024 at 12.30 pm.

The detailed disclosure with respect to the above as required under the SEBI Circular SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 is enclosed herewith as 'Annexure – I'.

(a)	the details of any change in the status and/or any development in relation to such proceedings;	As mentioned in the letter of Material Disclosure, the litigations / disputes with the Service Tax Authority, West Bengal was with respect to various matters relating to CENVAT credit availed on various services and service tax paid on commission received from outside India. The Company had disclosed the contingent liability of Rs 91.24 crores under the said matter. Aggrieved by the order passed by the Commissioner against the Company, appeal was filed by the Company. The matter was heard by CESTAT on February 7, 2024. Upon hearing both the parties, the CESTAT passed an order remanding the matter back to the Adjudicating Authority to, inter alia, examine the documents filed by the Company and to pass an appropriate order within 180 days from the date of receipt of Order after considering all the issues on merits as well as on limitation.
